No Chance for Souvenir Hunters, as Refuse Will Be Burned

CONCORD, N H, May 29-There is to be no opportunity for the sale of souvenirs of Pleasant View, the home in this city for many years of Mrs Mary Baker 67. Eddy, and now being raved by its owners, the trustees of the First Church of Christ, Scientist, Boston.

The staircases which Mrs Eddy climbed so many times in the 15 Years of ber residence at Pleasant View, the doors which she opened, the floors which she trod, the balcony from which she addressed thousands of "pilgrims," are not to be manufactured into paper cutters, penholders and stamp boxes.

Every vestige of Pleasant View is to be removed from the site it has occupled in Concord.

Josiah E. Fernald, one of the trustees under the will, said tought that the principal timber and parts of the house are to be used in the erection of a memorial to Mrs Eddy, in accordance with her will. The remainder will be burned. The site of the proposed memorial, Mr Fernals refused to divulge.

The contractor said that all the lumber from the house that was in good condition was to be shipped out of the city. That which he wished to burn was the refuse. It was learned that all the bricks from the fireplaces, before which Mrs fiddy was socustomed to sit, had been boxed up and shipped out of the city. the city.

A permit for regulated fires at the estate was later granted the contractor.
